DINU Result Area: Cargo distribution systems and storage capacities are improved in Northern Uganda

Brief description: DFID through a partnership with TradeMark East Africa will construct a Trade Logistics Hub in Gulu, which shall serve the trade corridors of (i) Kampala -Gulu - Elegu/Nimule-Juba and (ii) Gulu-Packwach Goli/Padea/Lia/Vura Democratic Republic of Congo. The Gulu Trade Logistics Hub is expected to improve capacity of transport infrastructure in Northern Uganda to serve markets in South Sudan, Northern Uganda and parts of DRC. The Hub will provide functions such as container and break-bulk, handling and storage facilities, space for stakeholders dealing with freight transport (freight forwarders, shippers and transport operators) and the provision of accompanying services such as customs inspections, tax payment, maintenance and repair, banking and information communication technology connections. The Hub is expected to improve capacity of transport infrastructure in Northern Uganda and to provide efficient management of freight transport through Northern Uganda; improve capacity to handle containers and other cargo in Gulu leading to quicker transit time and cost savings. The Hub will also provide for efficient humanitarian assistance; populations in Northern Uganda will benefit from cheaper products, including food, and connection to markets, thereby providing opportunities for increased exports and reduction in poverty.

Beneficiaries: Exporters and importers, transporters, including government agencies in Uganda, South Sudan, Kenya and Democratic Republic of Congo will benefit from quicker transit times and cost savings. Populations in Northern Uganda will benefit from cheaper products including food and connection to markets thereby providing opportunities for exports.

DINU Result Area: Increased production of diversified food and capacities of local government to deliver services to communities strengthened

Brief description: The project combines the physical construction of water reservoirs in two catchments in Karamoja with a strong focus on technical assistance at the national, regional and local levels to ensure the sustainability of this infrastructure. Through sustainable climate proofed water infrastructure built in Karamoja, the project will increase the availability of water for production through the construction of strategic water reservoirs (valley tanks) to better use seasonal water for livestock production. The project will provide financing for the construction, protection and rehabilitation of valley tanks of 20,000 m3 capacity in the districts of Kaboong/Karenga, Kotido, Amudat, and Moroto. Through strengthening of integrated catchment-based planning, management and development of water resources in Karamoja, the project will enhance the catchment management structures through technical advisory support at national, zonal, and local level and support the development of user agreements for the valley tanks in order to ensure proper operation and maintenance.

Beneficiaries: The project aims at reaching 20,000 direct beneficiaries, mainly among pastoralist communities in the selected districts

DINU Result Area: Increase market accessibility and support the private sector in developing decentralized rural electrification projects

Brief description: The goal of the action is to improve the social and economic conditions in Northern Uganda by providing electricity to increase business and employment opportunities and maximising the impact of electricity through improved production and resilience in the agricultural sector. The action supports this goal by creating an improved national framework for scaled up implementation of private, decentralised power distribution with participation by the private sector. During the action, up to 25 villages will be electrified with renewable energy-based mini-grids. On the ground, local communities and district officials are involved so as to plan implementation of the mini-grids projects in a manner that best addresses the needs of the local population. Impact of the electrification is maximised by supporting local industry to make use of electricity in areas such as pumping water, irrigating fields and milling or processing produce. The action addresses national policy and planning issues and uses a specially designed tender mechanism with the nationally mandated Rural Electrification Agency, in partnership with the electricity regulator for the application of licensing and tariff setting procedures for small scale off-grid projects. The villages supplied with electricity from privately operated mini-grids are further supported with measures to guarantee the affordability of electricity and the sustainability of the private operator's business model. These measures include on-going participatory planning, and electricity impact maximisation promoting the use of electricity machines and equipment to increase incomes, promote employment and improve resilience to climate change through advanced agricultural practices.

DINU Result Area: Transport infrastructure in the region are improved and climate-resilient				
Brief description: As part of improvement of the transport infrastructure and to increase trade of commodities within Northern Uganda and within the region, the Atiak – Laropi section (65.8km) of the Atiak-Adjumani-Moyo- South Sudan border road shall be upgraded to bituminous standard. The Atiak–Laropi road is a component of the 105 kilometres (65 mi) Atiak–Adjumani–Moyo–Afoji road. The gravel-surfaced road is dusty during the dry season. In the rainy season, the road develops gullies and presents navigational challenges. Civil works for upgrading to bitumen the road, which is part of the regional, national and international route connecting the remote north-western region of Uganda and Southern Sudan to Kampala, via the regional capital at Gulu, were commissioned on 11 September 2020. The project will contribute to improving road transportation and trade facilitation along the above-mentioned corridor and improving transport services and agricultural productivity by connecting remote and disadvantaged districts to the main road network. The work is contracted to Strabag International, a construction multinational, headquartered in Vienna, Austria. The construction bill is calculated at €54 million, jointly funded by the Government of Uganda (10 percent) and the European Development Fund (90 percent). Work started in March 2020, with completion expected in 2023. The work includes the construction of landing piers on both banks of the Albert Nile, one at Umi, Adjumani District and another, directly across the river at Laropi in Moyo District. The engineering supervision contract, worth €3.8 million is awarded to Eptisa Engineering Services.

A Programme Management Unit (PMU) under the overall technical supervision of the Permanent Secretary of OPM and the National Programme Coordinator (NPC) oversees the overall day-to-day management of the MAPE and the DINU programme. The OPM PMU consisting of management, technical, administrative support staff based in the liaison office in Kampala and in the regional offices in Gulu and Moroto, manages and implements the concrete MAPE-activities and components. A Technical Assistance Team (TAT) reports to the PMU and provides technical inputs and advice in the implementation of the various DINU-components.

Brief description:

The Action “Inclusive market-based development for smallholder farmers in Northern Uganda” is designed to increase food security, improve maternal and child nutrition and enhance household income in the nine districts of Karamoja Sub-region plus Katakwi District in Teso Sub-region. The Action supports that an estimated 68,250 women and men smallholder farmers in the beneficiary districts receive support to engage in diversified agricultural production and establish linkages to commercial input and output markets and financial services to engage in commercial agriculture allowing for improved food security and improvement of nutrition, specifically among children, women and adolescents. The Action applies a value chain approach linking groups of smallholder women and men farmers to the market and includes Kitgum business hub to ensure market linkages and engagement in niche markets. In agro-pastoral and pastoral zones of the Karamoja-Sub-region, smallholder farmers are living in *manyattas* with members of the *manyatta* moving

to different places over the year. In these areas, the Action will, where applicable, use the *manyatta* as a basis for the farmer groups (FGs) and adjust the approaches used to the *manyatta* structure. The Action includes specific and nutrition sensitive interventions and supports Sexual Reproductive Health and Rights (SRHR) and family planning (FP) and has a strong focus on gender equality and empowerment of women and youth. The Action is aligned with District Development Plans in the targeted districts and builds on the partners' extensive experience from working in Northern Uganda on market based diversified agriculture, value chains and market linkages, nutrition and SRHR and family planning.

Brief description: With a focus on all levels (district, sub-county and household) and selected value chains (VCs), the "Action for Livelihood Enhancement in Northern Uganda (ALENU)" enhances household resilience and developing agricultural market systems. It aims at changing food production and food consumption patterns through training and raising awareness as well as improving (input and output) market access to advance the livelihoods with a particular focus on improving nutrition and increase resilience of poor subsistence farmers in West Nile and Acholi. Male and female farmers trained in sustainable and climate-smart crop and livestock production are empowered to produce healthy and diversified food, whereby access to credit/ saving systems and improved market linkages allow for the procurement of inputs as well as generating income by selling surplus produce. Actors of the market system are supported through training in post-harvest operations and business development, and the identification of market opportunities and product niches allows producers as well as buyers and processors to tap into business opportunities. These will increase household income, strengthen acquisition of productive assets and contribute to the reduction of extreme poverty. A better understanding of prevailing challenges regarding improved (particularly child and maternal) nutrition and nutrition-related health issues will allow for effective communication campaigns, community-based nutrition initiatives, and the distribution of micronutrient supplementation and deworming. As a result, anaemia in children and pregnant or lactating women will decrease. More diversified agricultural production as well as increased income and better access to markets will additionally contribute to healthier diets. Awareness and knowledge creation on family planning and sexual and reproductive health-care services, empowerment of women, and the facilitation of access to family planning products will further help address nutrition and population growth issues.

Brief description: The Action “Building Resilience to Enhance Food and Nutrition Security, Incomes, and Health in Northern Uganda (BRENU)” seeks to enhance food and nutrition security, increase household incomes and improve maternal and child nutrition and health in Northern Uganda by promoting diversified food (and animal) production of resilient varieties; commercialising agriculture; improving post-harvest handling, food preparation and consumption practices; and encouraging family planning for improved and sustainable livelihoods. The major commodities with an emphasis towards commercialization include: Cassava, Rice and soybean. Other enterprises mainly aimed for food and nutrition security, dietary diversity and small-scale income generation include green leafy vegetables, orange fleshed sweet potatoes (OFSP) for Vitamin A, fruits, poultry, high-iron beans, yellow maize and groundnuts. Specific objectives are to increase food security, improve maternal and child nutrition and enhance household incomes through support of diversified food production and commercial agriculture, as well as improved household resilience to climate change and women and youth empowerment. The proposed Action targets two sub-regions of Lango and Teso in Northern Uganda. In Lango Sub-region, the Action will focus on five districts: Dokolo, Amolatar, Apac, Otuke and Kwania while in Teso Sub-region, the target districts are Amuria and Kapelebyong. The Action will target 51,250 households in Acholi and Lango sub-regions respectively. In all activities, there will be a recognition of women’s role and potential to influence household nutrition and food security and the nature of the age pyramid in the region, high youth unemployment and reproductive health challenges.

Brief description: The Action “Livelihoods Enhancement for West Nile and Acholi (LEWA)” has three priorities: 1) Increased production of diversified food 2) Increased market accessibility for smallholder farmers and 3) Improved maternal, child health and nutrition. It aims to reach 56,000 households as direct beneficiaries. These include 25,200 households practicing commercial farming in producer groups focusing on sim-sim, sunflower, and soybean value chains. It will involve training of government extension workers on modern and improved farming practices in specific value chains, climate smart agricultural practices and sustainable land use to support local farmer producer groups. With the aim of utilizing the public-private partnership approach and engaging the private sector to provide access to input and output markets, the Action will capitalize on the VEA model which will help to facilitate the necessary linkages to market actors for scaling up production and gaining access to market information via ICT platforms. The Action will not only support the establishment of the VSLAs but train them in business skills development and incubation services (such as financial literacy, record keeping, business Action planning etc) so they can develop the needed know-how and the confidence to run a business, while also facilitating partnerships between VSLAs and financial institutions to increase the lending and saving schemes of the groups. Digitalization of 400 of the 840 VSLAs will be done with the purpose of enhancing the quality of the integrity of their records which boosts the effectiveness of linkage with financial institutions. To achieve improved maternal child health and nutrition in Acholi and West Nile sub-regions, the Action will ensure that there is increased adoption of good nutrition and health practices, and increased access and utilisation of family planning services. The Action will build the capacities of VHTs and health workers to increase awareness and provide age appropriate family planning services respectively. All these will lead to improved community-based nutrition interventions and increased use of family planning methods (utilisation): Other nutrition initiatives including micro-nutrient supplementation & deworming, promotion of maternal and children under five feeding practices, hygiene and sanitation and childcare complement diversified food production.

Brief description:

The Action “Chase Poverty and Hunger: Diversifying food systems for poverty reduction, food and nutrition security and inclusive development in Northern Uganda” is grounded on three Result Areas and seven main activity clusters of the DINU programme, namely 1) increasing the diversity, productivity and production of crop and animal product; 2) established networks of platforms (the “village super market”) for low-cost access to inputs and produce markets; 3) promoting village savings and credit schemes for increased participation of value chain actors in the monetary economy for inclusive growth 4) forging or strengthening linkages across actors in the selected commodity value chains; 5) promoting Business to Business (B2B) match-making models to promote contract farming for effective market access; 6) establish and consolidate agriculture-health nexus in district and community advisory services; and 7) establish communities of active practitioners of inclusive family planning and responsible child spacing in Acholi and Lango sub-regions. At impact level the: 1) increasing production of marketable surplus will contribute to: 1) poverty reduction, increasing production and diversity of foods provides for food security and rational choices of foods for nutrition 2) reducing the proportion of child and human population undernourished and/or suffering from preventable diseases; and 3) increasing household incomes, quality of dwelling and household assets and improving living standards.
